Chairman Saldaña called the meeting to order. Member Currie moved to approve the minutes and the Executive Session minutes of March 8, 2012. It was seconded by Vice Chairman Cullins. Motion carried. They explained they wish to open a place for Students over 21 and Staff of the College to interact, in addition to the General Public. They will have a scanner to scan drivers' licenses with wrist bands for patrons over 21. This will be for on premise sale only/no off sale. and it was suggested she submit pictures of the boundaries documenting the area. Member Mathis made the motion to approve a 90 day conditional approval pending all the permits are received. Member Currie seconded the motion and it was carried.
